### *Frequently Asked Questions*

#### **WHO GIVES TO THE FACULTY STAFF CAMPAIGN?**

Everyone who wants to! All full-time and temporary employees are encouraged to participate in the Faculty & Staff Campaign. Those employees who are alumni of Indiana State University will also have their contributions counted in alumni participation rates.

#### **WHY AM I BEING ASKED TO GIVE?**

It is important that as we ask our alumni and friends to support Indiana State that the Faculty and Staff of the university send a powerful message through their participation in the campaign. You as an employee have first-hand knowledge of campus programs and have great insight to the university's needs and the fulfillment of those needs. Giving to Indiana State demonstrates your belief in the value of our university, our programs and our commitment to community engagement and experiential learning.

#### **CAN I SPECIFY WHERE MY CONTRIBUTION CAN GO?**

Of course! You can designate your gift to your own department, college or a campus program that inspires you. Simply note your preference on your gift card.

#### **HOW MUCH AM I EXPECTED TO GIVE?**

Participation is how we measure our success. We would like 100% participation rates from ISU Faculty and Staff. Every donation counts, whether it's \$5, \$50, \$500 or more.

#### **CAN I MAKE AN ANONYMOUS GIFT?**

Yes, simply indicate who you would like to benefit from your contribution, and mark your pledge card that you would like to remain anonymous.

#### **ARE GIFTS TAX-DEDUCTIBLE?**

Yes, your gift to the campaign is recognized to be a charitable contribution by the IRS.

#### **WHAT IS PAYROLL DEDUCTION?**

Payroll deduction is one of the most convenient and popular ways to make a gift to ISU. You determine the amount of your gift which will be deducted monthly. It begins immediately upon your request and will renew until you contact us. Payroll deduction contributions quickly add up to a substantial gift.

#### **WHAT IF I HAVE AN EXISTING PAYROLL DEDUCTION?**

If you are currently donating to the campaign through the payroll deduction system, then you are currently being counted in the Faculty Staff Campaign.
